Section I

1. All submissions of any form and/or format, either solicited or unsolicited, by designers, artists, agents, assignees or any other entity, to Bushland Outfitters for review and/or consideration for possible selection to be incorporated into Bushland Outfitters Art Gallery, Designers Den or for any other purpose determined by Bushland Outfitters Directorate are presented to Bushland Outfitters for no financial re-numeration, reward, recognition or compensation to aforementioned submitter(s) of submitted work(s). Any and all items submitted to Bushland Outfitters for the aforementioned are submitted without reservation or expectation of being returned, recognized, or compensated for work, and the submitter of said works submits work as a sample piece to Bushland Outfitter.

2. All submissions of any form and/or format either solicited or unsolicited by artists, agents, assignees or any other entity to Bushland Outfitters for review and/or consideration for possible selection to be incorporated into Bushland Outfitters Art Gallery, Designers Den, or for any other purpose determined by Bushland Outfitters Directorate; said submitter, hereby attests and swears under the penalty of perjury and subject to all civil and criminal penalties that said submitted work(s) is his or her own creative work; created by them and is not a copy, re-production, facsimile, forgery, likeness, counterfeit , plagiarized, reprint, or any other act of fraud. All work submitted is of original content conceived from the fertile minds of the artist or designer who has submitted them.

3. Submission of all works can be made by e-mail, fax, Drop Box, USPS, FedEx, UPS, or other means to Bushland Outfitters Operations Center, 555 E. Union Street, Pasadena, CA 91101 USA, and must be accompanied by a signed copy of this document. Submissions by email must include a scanned copy of this signed document.

SECTION II: CRITERIA FOR DESIGNERS DEN SUBMISSIONS



1. All submissions must be of original creation and workmanship.
2. Name of artist/designer and contact information must be included.
3. All Designers Den submissions must include at least one set of Bushland Outfitters Trademarked Grizzly Bear Paw prints of *minimum* size of -1³/₄" x 1" - taken from the Bushland Outfitters Trademarked Grizzly Bear Paw prints image as shown above. Designers Den designer submissions are granted a one-time only use by Craig Bonholtzer, President Bushland Outfitters, solely for submission purposes only to Bushland Outfitters Designers Den Directorate of the Bushland Outfitters Trademarked Grizzly paw prints for use on said submission. Any submission to the Directorate must meet the aforementioned clauses in Section I & Section II, of the Bushland Outfitters Designer Den and Artist Release & Affidavit.
4. The one-time only use of the Bushland Outfitters Trademarked Grizzly paw print may not be used for any purpose other than submission to Bushland Outfitters. No sale, reproduction, copy, facsimile, or any other form of copy of the Bushland Outfitters Trademarked Grizzly paw print is allowed. Any use of the Bushland Outfitters Trademarked Grizzly Bear Paw Prints for any purposes, other than the aforementioned submission, will be pursued with all civil and criminal actions allowed by law.
5. Only original sketches will be accepted, and must be sent to Bushland Outfitters Designers Den Directorate at 555 E. Union Street, Pasadena, CA 91101, or by email to terrafirma@bushlandoutfitters.com with a note in the subject line stating "Designers Den" and must be accompanied by a signed copy of Sections I, II & III of the **Bushland Outfitters Designers Den or Artist Release & Affidavit**. All work is considered to be a sample piece and will not be returned.
6. All items submitted for consideration should be wearable, comfortable garments, with a suggested retail cost not to exceed \$250.00 per item, and so the manufacture of the garment including fabric and labor should not exceed \$140.00 per item.
7. If submitted design is chosen for further consideration, the designer will be contacted and asked to make possible modifications or alterations to their design sketch or to make a sample garment with possible modifications or changes. However, even if a designer is chosen to make changes, alterations, or a sample garment, there is no guarantee that the design will be put into production. It will simply mean that the garment has reached the second stage of the selection process and no compensation is given at this stage.

8. If the design is chosen for the final step into production, the designer will be paid a one-time fee of \$500 US (Five Hundred U.S. Dollars) for all rights to the design upon completion of all items in Section III of this document. The selected designers will be paid said sum for approved works upon completion of this project and will relinquish all rights to said work(s) to Bushland Outfitters for use in any purpose, manner, media, or form in perpetuity of said works, as well as designer name and likeness for any purpose, manner, or form in perpetuity of said works. Selected designers will be considered as independent contractors and not employees or agents of Bushland Outfitters.

9. Once a designer is approved and has agreed to all terms and conditions in Sections I, II, and III, they may use the image only of the work provided to Bushland Outfitters, and only after approval from Bushland Outfitters for the use of that image in their resume, advertising in their own design line, exhibition, or other use after receiving written permission from Bushland Outfitters for the use of these images.

SECTION III: Designer Process for Selected Designs

1. Once approved and contacted by Bushland Outfitters Design Directorate, Designer will be given a time frame to submit the following:

- a. Sketch or other representation of final design including any modifications requested by Bushland Outfitters Designers Den Directorate.
- b. Patterns, molds, or other means for production of accepted work.
- c. One fully finished sample garment including any requested modifications.
- d. Listing of suggested fabrics/materials to be used in the production of selected garment.
- e. A price list of costs for fabrics, materials, and/or any incorporated items needed for item production.
- f. Availability and location for obtaining materials listed in Item "e" above.
- g. Estimated cost of construction/assembly per unit for a 25 unit production of said work.
- h. Signed confidentiality agreement between Designer and Bushland Outfitters.

2. Chosen Designers will be required to hand sign 25 copies of their final sketch, one of which will be included with each sale of the garment and will be provided by Bushland Outfitters. This sketch will also include a photograph and brief biography of the designer. As Each winning designer's photograph and brief biography will be featured on the Bushland Outfitters' website. Photos will be taken by a professional photographer provided by Bushland Outfitters.
